

Logon





On launch, you will be asked to enter your FundNet logon credentials.

- 1 Enter your FundNet User Name
- 2 Enter your FundNet User Password
- 3 Tap the "Logon" button to be authenticated and directed to the Home screen (page 6).
- 4 Toggle on or off "Remember Me", where the app will remember your logon credentials for future use.









Bookmarks




Used to search for a specific article or resource within the app. Search currently looks for keywords in the article title, and does not do advanced lookups.

Searchable Content:

- -The Fund Title Notes
- -Fund Concept Articles
- -General Counsel News Articles
- -News & Alerts posts
- 1 Tap the form field to open the onscreen keyboard and type your search keyword.
- Select the section of the app you would like to search. You cannot search more than one section at a time.
- 3 Tap the "Search" button to begin your search. You will be taken to a results screen where your results will be displayed (page 9).


Displays search results from your keyword search.



Premium Calculations



This is the Premium Calculations Calculator.

- 1 Tap to select the policy Issue Type.
- 2 Tap to select the Property Type.
- Tap to select if the policy has Endorsements. If 'yes' is selected, an Endorsements tab with available endorsements will be shown.
- 4 Enter the policy insurance amounts for the main policy and any simultaneous policies (enter numbers only, do not enter any non-numeric characters such as dollar signs, periods etc).
- 5 Tap the "Calculate Results" button to calculate the estimated premiums due.
- 6 Tap the "Clear Calculator" button to start over and remove any data you may have entered into the calculator.
- Tap the "View Details button to view the expanded results for the current premium calculation. This will display an in-depth look at all of the premium rates and calculations (page 12).
- 8 Displays the results of the premium, Old Republic due and TRID due premiums from the calculation.


Premium Calculations - Expanded Results

Closing Costs





This is the Closing Costs Calculator.

- 1 Enter the purchase price of the property (enter numbers only, do not enter any non-numeric characters such as dollar signs, periods etc).
- 2 Enter the mortgage amount for the property (enter numbers only, do not enter any non-numeric characters such as dollar signs, periods etc)..
- 3 Select the property type, Single Family Residence or Condominium.
- 4 Enter the percentage of real estate commission.
- 5 Enter Adjustable fee amounts and select which party, buyer or seller, is paying the fee (buyer will be default selected).
- Tap to select which party, buyer or seller, is paying the unadjustable fees (buyer or seller will be default selected).
- 7 Tap the "Calculate Results" button to calculate the total owed at closing by the buyer and seller.
- 8 Tap the "Clear Calculator" button to start over and remove any data you may have entered into the calculator.
- 9 Displays the calculated results for the amount of money due at closing by buyer and seller.








































